FACULTY AWARDS

OUTSTANDING FACULTY AWARD*

The Outstanding Faculty Award is for excellence in teaching, scholarship and service.

NEW TEACHING AWARD

Awarded to an individual prior to receiving tenure who has demonstrated outstanding potential and commitment to the teaching profession. Teaching experience may include that done prior to Cal Poly.

SUSTAINED EXCELLENCE IN TEACHING AWARD

Awarded to a tenured individual with distinguished teaching service.

OUTSTANDING LECTURER AWARD

This award is for distinguished teaching excellence as a lecturer.

NEW SCHOLAR AWARD

This award is for outstanding research accomplishments at Cal Poly by a pre-tenured faculty member.

SUSTAINED EXCELLENCE IN SCHOLARSHIP AWARD

This award is for outstanding research accomplishments at Cal Poly by a tenured faculty member.

STAFF AWARDS

OUTSTANDING STAFF AWARD

The Outstanding Staff Award is awarded to an individual staff member with a consistent record of commitment and excellence in their contributions to the College and University. The nominee must work full time in the College of Agriculture, Food and Environmental Sciences and have a minimum of three years' service to California Polytechnic State University.

EARLY CAREER STAFF AWARD

This award is for individual staff members with less than three years of service to California Polytechnic State University who have made an outstanding contribution to the College.

FACULTY OR STAFF AWARDS

DEAN'S SPECIAL RECOGNITION AWARD

To be given on an as-appropriate basis for outstanding contributions to the College by faculty or staff.

CAFES OUTSTANDING MENTOR AWARD

This award is for distinguished service and excellence as a mentor to students, faculty or staff.

^{*} Faculty nominee must teach full-time in the College of Agriculture, Food and Environmental Sciences, with a minimum of three years' service to California Polytechnic State University at San Luis Obispo.

CAFES DIVERSITY AND INCLUSION AWARD

This award celebrates members of the Cal Poly community who have exhibited exceptional commitment to enhancing campus climate. Faculty will be evaluated by the following criteria: 1) Recognized by the community as a person who engages in diversity and inclusion through their work in the classroom and curriculum; 2) Supports students by mentoring and raising awareness of diversity and inclusion both inside and outside the classroom; 3) Pursues scholarship that connects their work to diversity and inclusion; and/or 4) Supports colleagues in efforts to create a welcoming campus climate. Staff will be evaluated by the following criteria: 1) Demonstrates inclusive excellence through programs, initiatives and/or daily actions; 2) Strives for improvement of campus understanding of diversity, and/or 3) Service goes above and beyond duties to support campus climate.
